Rules & Regulations

1	Overview
1.1	The Yorkshire Netball Premier League and League One is a regional competition. The competition is organised by Yorkshire Netball to enable clubs to compete against each other to determine a regional winner. The purpose of regional competition is to provide the highest level of regional competition at an amateur level, whilst encouraging participation and development in netball through an open, fair, progressive, and transparent league structure.
	The winner of the Yorkshire Premier League will be the club/team that goes forward to the England Netball Premier League Playoff's (unless they already have a team in competing in the league). If that club is already represented in the England Netball Premier League, the next highest team in the Yorkshire Premier League who is not represented will go forward to the playoffs.
	Should a club decline going forward to the England Netball Premier League Playoff's then their inclusion in the following season may be reviewed.
1.2	These regulations set out below outline the Rules and Regulations which govern the operation of the Yorkshire Netball Premier League and League One.
1.3	These regulations must be followed by all teams, players, officials, spectators, and administrators involved in the management, administration, and operation of the Yorkshire Netball Regional League.
1.4	All teams will be held responsible for the behaviour, demeanour and actions of their Players, Team Officials, and spectators.
1.5	Codes-of-conduct.pdf (d2cx26qpfwuhvu.cloudfront.net) It is the responsibility of all Team Officials, not Yorkshire Netball to ensure that all players and relevant parties within the team are fully conversant with these regulations.
2	Competition Structure
2.1	The competition shall be known as the Yorkshire Netball Regional League Competition .
2.2	There are two distinct elements to the Competition. The league structures (Yorkshire Premier League and Yorkshire League One) and the Yorkshire Netball Regional League Playoff's. These Competition Regulations cover all matters relating to the League structures, and the Yorkshire Netball Regional League Playoffs have a separate set of Competition Regulations that are solely specific to that Competition.
2.3	Yorkshire Netball Regional League Competition shall comprise of the following divisions, each compromising of ten (10) teams. - Yorkshire Premier League - Yorkshire League One

- Disqualification of any individual Player or Team.
- Adjudicating instances of unsportsmanlike behaviour or behaviour that brings the sport into disrepute including but not limited to instances of teams predetermining or attempting to predetermine the outcome of a match and/or the competition.
- Determining the result and score should any match not be concluded due to any unforeseen circumstance.
- Determining any matter not covered specifically within the regulations
- 4.3 The competition referee may call upon, or delegate to, additional persons to assist with the competition or consult with other persons prior to making any decision, However the final decision and accountability for the decision will rest with the competition referee.
- 4.4 The competition referee will maintain and be responsible for a confidential competition referee logbook where appropriate.

5	Pre-Competition Management & Administration
5.1	Team Entry and Eligibility
5.1.1	Entry into the Regional League Competition shall be open to clubs/teams which is an active club registered on the England Netball Membership System (ENgage), through a County Association, which has paid its membership fees in this respect, and is situated within the boundaries of a County Association which is a member of the Regional Association.
5.1.2	 By entering the Yorkshire Netball Regional League Competition clubs/teams agree that A minimum of Level 2 Coach present on match day (this may be a player coach) A primary carer / first aider presents on match day (This cannot be the Coach, but this may be a player) Safeguarding Officer (this cannot be the coach) present on match day where an under 18 is listed in the squad. CAPS or equivalent accreditation in place or actively working towards – where working towards – This element is currently on hold pending an update from England Netball. Once England Netball have confirmed what this looks like the region will put steps in place to introduce and for clubs/teams to achieve. Further information and discussions once this is known. Able to identify a (minimum) B award umpire to umpire allocated fixtures during the season.

5.1.3	Yorkshire Netball are entitled to charge an entry fee to complete in the Yorkshire Netball Regional League Competition and this must be fully paid in full within the permitted the scales for a team to participate.
	For the 2024/25 season this fee is £60.00 per team, payable before the first game of the season.
5.1.4	A club may have upto a maximum of three (3) teams in the Competition, but no more than two (2) teams in anyone division.
5.1.5	 By entering a team in the Regional League Competition, clubs/teams agree that. they are able and willing to fulfil the costs and commitment of participation in the Regional League Competition. they will fulfil their obligations and responsibilities as set out in these regulations. they are bound by the competition regulations and they are bound by all the rules, policies, regulations, and by-laws of Yorkshire
	Netball, including the England Netball Code of Conduct and Disciplinary Regulations
5.2	Player/Team Official Eligibility
5.2.1	In order to participate in the Regional League Competition all Players and Team Officials (see 6.5 for details of Team officials) must be a member of England Netball as a personal adult/junior member participant, having paid the full membership fee due and received confirmation of their membership in advance of submitting the Squad Registration Sheet.

All players must be over 14 years old as at 11.59pm on the 31 August immediately prior to the commencement of the playing season in which the Regional League Entry Tournament takes place, unless they have completed an Age Banding Consent Form and submitted it with the Squad Registration Sheet.
England Netball Age Banding Guidance – England Netball Competition Governance
During all matches of the Regional League Competition, Team Managers must always carry proof of age for all players under the age of eighteen and a copy of all Age Banding Consent Forms applicable to players listed on the Squad Registration Sheet.

 Any player who takes to court without meeting the eligibility criteria will be defined as an unregistered player and will be sanctions in line with 4.2
The Regional League Competition is a competition for female players. Only female
participants can be included on the squad registration sheet as a player. For more

Yorkshire Netball recommends that individuals (player, coach, umpire) if pregnant should only participate with approval from their doctor and in accordance with any guidance issued by itself.
·
The England Netball personal accident insurance excludes any loss or expense due to pregnancy, childbirth, miscarriage, or any consequence thereof. If, for example a member who is pregnant is involved in an accident not related to the pregnancy, subject to the conditions of the policy, the relevant benefits would be payable. However, if any situation (such as hospitalisation) was prolonged as a direct result of pregnancy, pregnancy complications or even early childbirth, then this portion of any claim is not covered.
A player may not play in two (2) Geographically different Regional Leagues (e.g., Yorkshire Regional League and Northeast Regional League) during the same season.
Registration of Squads
Participating clubs/teams must complete a squad registration sheet fully listing each player and their membership numbers. This needs to be lodged with the competition organiser one (1) week prior to the commencement of the Regional League Competition.
Squads entering the league through the Regional Playoff's (to determine entry to the league) remain with that squad for the season and as such must be included on the team registration sheet.
Teams may only use those Players whose names appear on their Squad Registration Sheets held by Yorkshire Netball (see Section 4.2 for the penalty breach for this)
Any additions to the Squad Registration Sheet, must be lodged with the competition working group (yncompetition@gmail.com) by 12.00noon on the Saturday prior to the match taking place.

	Additional registrations of Players will not be accepted after 12:00noon on the Saturday prior to the Regional League Competition Round 15 (9 February 2025).
5.3.4	A player may seek to transfer to another club/team after the start of the Yorkshire Netball Regional Competition if both teams are in agreement. Transfer requests must be made in writing by email to yncompetition@gmail.com with both clubs copied into correspondence.
	The request must clearly outline why the request is being made. The team/player requesting the transfer will be notified in writing of outcome of the request.
	Players will not be allowed to request to transfer to another club/team after 12noon on Saturday 11 January 2025.
5.3.5	Each team may declare up to twelve (12) Players prior to the start of each match by completing the Yorkshire Netball Results Sheet and submitting it to the Officials Bench.
5.3.6	Only Players who have taken to the court (played at least one (1) quarter (or part quarters thereof) in Rounds $1-18$ during the course of the season will be eligible to compete for their registered team within the Yorkshire Netball League Playoff's for that season.
5.3.7	Clubs who have more than one team in the Regional League Competition must register their squads as detailed, and the following shall apply.
	 Where clubs have two (2) or three (3) teams in the competition, the League One nominated players may 'play up' for the Premier League Team (where a club has more than one team in the Premier League then the player is only able to play up for one team) for a maximum of 18 quarters (or part quarters thereof), thereafter they will be tied to the higher level and identified as a permanent member of that squad and will no longer be able to play down. (this includes in any Regional League Playoff's).
5.3.8	 A player that is 'playing up' may only play for one (1) team per match day. Clubs whose players are registered for a Regional League Team may 'play up' for 18
	quarters (or part thereof) for their Premier League Team (where part of the England Netball Premier League Competition). Players will then become ineligible to play again in the Regional Team in the Regional League or Regional League Playoff's.
5.3.9	No player who has played in the Yorkshire Netball Regional League Competition can within the same season play for any other club/team in any Regional League, or England Netball Premier League (Including England Netball Playoff's) e.g., a player playing for Chevrons in Yorkshire Premier League could not play for Grangetown in the Northeast Regional League and/or England Netball Premier League.
5.3.10	For clubs/teams looking to enter the Yorkshire Regional League Competition via the playoff's, they cannot use any players who have competed in any regional competition that season for the playoffs. E.g., a player who has played for a club in the Northwest regional League would not be eligible to play for a team from West Yorkshire at the regional playoffs.
5.3.11	Players who participate in the England Netball Premier League can play in Yorkshire Premier League. No players who play in the England Netball Premier League are permitted to play in Yorkshire League One.

	The rules around squad registration as outlined in 5.3.7 / 5.3.8 / 5.3.9 will also apply.
5.3.12	No player, once registered with a Super League Team, may play in the Regional League. An NSL training partner is allowed to play in the Yorkshire Netball Regional League in the Yorkshire Premier League only and only until they are promoted to a registered Super League Player.
5.3.13	Overseas players or an International Sportsperson Visa are NOT permitted to play in the Yorkshire Netball Regional League Competition.
	Individuals who have indefinite leave to remain or are seeking asylum are permitted to play in the Yorkshire Netball Regional League Competition.

Responsibility for ensuring that players taking the court meet the eligibility criteria specified rests solely with the relevant club/team. All eligibility checking by the Competition Working Group /

Competition Referee will be undertaken by reviewing submitted results cards and squad registration sheets after matches have taken place.

5.4 Competition Venues

- 5.4.1 Matches must be played on an indoor court. The court should be made of an adequate playing surface (preferably wooden sprung) and preferably with adequate surrounds. If not sunken posts, the posts should be securely fixed to the floor with post protectors as standard.
- 5.4.2 All venues should have ancillary facilities, including changing facilities.
- 5.4.3 Venue Arrangement and Costs

For Yorkshire Premier League

- the home team is responsible for arranging the venue, and for the costs of this.
- it is the responsibility of the home team to conduct a risk assessment prior to each match. Umpires will undertake pre-match checks to ensure the match is safe to play. It is within their jurisdiction not to allow a match to go ahead if not deemed safe to do so. In instances where risks have been identified, a copy of the risk assessment should be sent to Yorkshire Netball.
- for all 'incidents' on or off the court at a Match an England Netball Accident Report form must be competed, and a copy sent to the Yorkshire Netball Competition Working Group, which will be stored for insurance purposes.

For Yorkshire League One

- Yorkshire Netball are responsible for arranging the venue, teams will pay a match fee, which for the 2024/25 season is £32.00 per team per match. Fees can either be paid per fixture (in the week leading up to the fixture taking place) or in advance at the start of the season.
- Umpires will undertake pre-match checks to ensure the match is safe to play. It is
